

Dear Partner,

As we have informed you in our netbank messages, emails sent to your specified email address, and announcements posted on our website, on 28 February 2020 Virpay Pénzforgalmi Szolgáltató Korlátolt Felelősségű Társaság (the "**Company**") has ceased to provide payment services and the financial regulator has revoked its licence. Accordingly, the payment account agreement concluded by and between You and the Company has been terminated and our customers have been requested to declare to which beneficiary and to which bank account they require us to pay the balance of their current account held by the Company.

In our communications, we have indicated that we are currently in a position to pay out [74,2468 %] of the balance of payment accounts (the "**Payable Customer Balance**") as a result of an official measure of the authority, and the remainder will be paid after such act of the authority is terminated. We do not yet have any information on the date of termination of the official measure.

In our communication, we have also informed our customers that if there is outstanding balance on their payment account held by the Company after 27 February 2020, then the Company will deposit it at the escrow account of Dámosy Law Firm (H-1054 Budapest, Szabadság square 7) on 28 February 2020.

As of today, we have not received a declaration from You - due to termination of our payment account service - as to which beneficiary and into which bank account you are requesting to pay your Payable Customer Balance.

You may provide your payment declaration in the following ways:

- Until 31 March 2020, the payment declaration can be submitted to us via our netbank. We kindly ask you to please follow the terms of the settlement informative available on our website (www.virpay.eu) where You will also find, the template form of your payment declaration;
- From 1 April 2020, please send us the payment declaration attached to this letter to our postal address indicated in this letter by mail in an original, duly signed by the authorized representatives in a duly authenticated letter, in a private deed of full probative value including a copy of the following
 - a) in case of natural person
 - in case of resident customers their identity card, passport, driving licence or any other document qualifying as a document of identification and address card;
 - in case of non-resident customers their travel document (passport) or identity card.
 - b) in case of entity with or without legal personality or other legal entity („**Legal Entity**”)
 - the documents referred to under point a) of a person authorised to act and sign the payment declaration on behalf of the Legal Entity; and
 - a certified document dating not older than 30 days certifying that the business organisation is registered by the Company Court (i.e. company registry excerpt), in case of sole entrepreneur a certificate for the request of registration or certificate of registration; in case of other resident legal entities if their establishment requires the registration of an authority or court, a proof of such registration;
 - in case of non-resident Legal Entity, a document dating from not older than 30 days that it is duly registered as required by law of its own country and the Legal Entity is an existing legal person.
